

**MECHANISMS OF FORMATION OF LEGAL AWARENESS AND LEGAL CULTURE
IN THE FAMILY ENVIRONMENT**

Abstract: This article analyzes the process of formation of legal consciousness and legal culture in the family environment, the main factors and mechanisms influencing it. It highlights that the family, as the smallest social unit of society, is an important place that determines the legal views, behavior and social responsibility of the individual. The study examines the impact of parental legal literacy, educational approaches, the communicative environment in the family, the media, digital culture and the education system on family legal culture. The data presented in the table show that the majority of parents have an average level of knowledge on legal issues. Although awareness of children's rights and Internet safety is relatively high, the skills for legal resolution of family disputes are not sufficiently developed. This indicates the need for additional educational and explanatory work to strengthen legal culture in families.

2. Observation method.

The nature of educational processes in families in natural conditions, the legal literacy of parents, the style of communication with children, and the influence of the family environment on legal culture were analyzed through practical observations.

The data presented in the table show that the factor that has the strongest influence on the formation of legal culture in the family is the personal example of parents. The quality of communication in the family also has a high impact and is an important tool in the formation of legal awareness. School and family cooperation plays a significant role in ensuring sustainable social education. The influence of the media and the Internet can be both positive and negative, so it requires control and proper guidance. In general, the formation of family legal culture is a multifactorial process, in which the harmony of the psychological, social and information environment is of great importance.

Interview and interview method.

Through interviews with parents, teachers, psychologists and young people, practical information was obtained about the level of legal education in the family, existing problems and experiences.

2. Questionnaire method.

Based on a regional sample, questionnaires were distributed among respondents belonging to different age and social groups, and statistical data were collected on the factors affecting the formation of legal awareness in the family, the level of legal literacy of parents, and the legal behavior of young people.

The indicators presented in the table confirm that the most effective method of providing legal education in the family is teaching through conversations and practical examples. Legal videos and shows, although they have a positive effect, serve only as an additional tool. In general, the effectiveness of legal education in the family is directly related to regular communication, consistent explanations and the involvement of the child in practical processes.

5. Method of comparison and analysis.

The obtained theoretical and empirical data were compared and conclusions were drawn on the mechanisms of influence of the family on legal culture.

6. Modeling method.

Based on the research, a conceptual model was developed that represents effective mechanisms for the formation of legal consciousness in the family. The model was formed on the basis of a combination of socio-psychological, pedagogical and communicative factors.

When the theoretical and empirical data obtained through comparison and analysis methods were studied in comparison with each other, it was found that the formation of legal consciousness and legal culture in the family occurs based on the interaction of many factors.

It was found that the most effective methods are teaching through practical examples and family conversations, as well as the consistent use of incentive and discipline systems. After analyzing the theoretical and empirical data obtained, a conceptual model of the formation of legal awareness in the family was developed. This model allows for the systematic development of legal culture based on a combination of psychological, pedagogical, and communicative factors.

In general, the study showed that in order to improve legal culture in the family:

1. Increase the legal literacy of parents;
 2. Strengthen family communication and widely use practical educational methods;
 3. Establish effective cooperation with schools and other educational institutions;
 4. It is necessary to direct the information and digital environment for positive purposes.
